INCREASED FAMILY INCOMES WILL RESULT IN GREATER ACCESS TO EDUCATION FOR THE CHILDREN, IMPROVED NUTRITION FOR THE ENTIRE FAMILY AND A HIGHER QUALITY OF LIFE.
